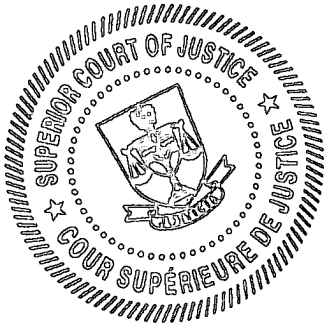

JUDGMENT

THIS ACTION, was heard May 28, 29, 30, June 2, 3, 4, and 5, 2014, without a jury, at 114 Worsley St., Barrie, Ontario.

ON READING THE PLEADINGS AND HEARING THE EVIDENCE and on hearing the submissions of counsel for all parties,

1. THIS COURT ORDERS AND DECLARES that the counterclaim and third party claim of Premier Salons Ltd. are dismissed.



2. **THIS COURT ORDERS AND DECLARES** that the defendant, Premier Salons Ltd., shall pay to the plaintiff, Grossi Consulting Services Limited, \$75,000.00, plus prejudgment interest of \$2,455.24 calculated from February 22, 2012, to August 29, 2014.
3. **THIS COURT ORDERS AND DECLARES** that the balance of the relief sought in the statement of claim is dismissed.
4. **THIS COURT ORDERS AND DECLARES** that the above amounts will accrue post-judgment interest from August 29, 2014, at a rate of 3.0% per annum.
5. **THIS COURT ORDERS** that Premier Salons Ltd shall pay costs to Grossi Consulting Services Ltd., Al Grossi and Angelina Grossi in the amount of \$35,000.
