- 1. THIS COURT ORDERS AND ADJUDGES that the corporate defendants Gametronics Gaming Equipment Limited, Internet Gaming Software Solutions Limited and Pong Media Inc. shall pay to the moving parties Janis Valentine, Hongkun Wang, Jian Guo Miao, Eric Terro and Wu Zhu the amount of \$80,753.13 to be distributed in the following way:

 - (ii) \$4,800.00 in unpaid vacation pay;
 - (iii) \$26,666.66 in lieu of notice for wrongful dismissal.

 - (i) \$6,009.60 in unpaid wages;
 - (ii) \$4,999.99 in unpaid vacation pay;
 - (iii) \$2,403.84 minimum pay in-lieu of notice per *Employment Standards Act*.

- (c) Jian Guo Miao
 - (i) \$5,769.25 in unpaid wages;
 - (ii) \$3,360.01 in unpaid vacation pay;
 - (iii) \$2,307.70 minimum pay in-lieu of notice per *Employment* Standards Act.

TOTAL: \$11,436.96

- (d) Eric Terro
- (i) \$4,326.90 in unpaid wages;
- (ii) \$3,239.98 in unpaid vacation pay;
- (iii) \$1,730.76 minimum pay in-lieu of notice per *Employment* Standards Act.

TOTAL: \$9,297.64

(e) Wu Zhu

- (i) \$5,288.45 in unpaid wages;
- (ii) \$1,100.00 in unpaid vacation pay;
- (iii) \$1,057.69 minimum pay in-lieu of notice per *Employment* Standards Act.
