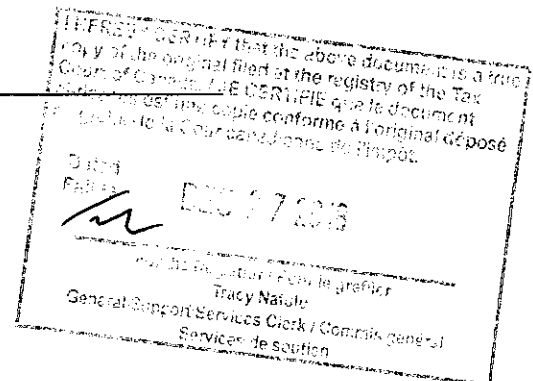
JUDGMENT
