Book in Trust", the sum of twenty-five thousand (\$25,000.00) dollars together with accrued interest being a return of the security posted

by the Plaintiff, to the law firm of "Torkin Manes LLP in Trust" the sum of one thousand, five hundred (\$1,500.00) dollars being the costs ordered by Chalmers J. on June 11, 2020, and to "Ira E. Book in Trust" the sum of four hundred and ninety-eight thousand, five hundred (\$498,500.00) dollars comprised of the balance of the monies paid into court pursuant to the two interpleader orders together with any accrued interest, was read this day at the courthouse, 330 University Avenue, Toronto, Ontario, M5G 1R7.

ON READING the Motion Record of the Plaintiff including the Affidavit of Ira E. Book sworn October 17th, 202, together with the Exhibits referred to therein and the Consent of the parties, filed:

- 1. THIS COURT ORDERS on consent that the Accountant of the Ontario Superior Court of Justice do pay out of the funds held to the credit of this action, to "Ira E. Book in Trust", the sum of twenty-five thousand (\$25,000.00) dollars paid into court by the Plaintiff as security for costs together with any accrued interest.
- 2. THIS COURT ORDERS on consent that the Accountant of the Ontario Superior Court of Justice do pay out of the funds held to the credit of this action, to the law firm of "Torkin Manes LLP in Trust", the sum of one thousand, five hundred (\$1,500.00) dollars for costs pursuant to the interpleader order of Chalmers J. dated June 11th, 2020.
- 3. THIS COURT ORDERS on consent that the Accountant of the Ontario Superior Court of Justice do pay out of the funds held to the credit of this action to "Ira E. - 6. THIS COURT ORDERS that this Order shall take effect immediately without it being entered.
