- 1. THIS COURT ORDERS AND ADJUDGES** that the claims of the Plaintiffs, Priyanka Concessio and Johnny Carcamo against the Defendants are allowed, and that the Defendants shall pay to the Plaintiffs **\$208,854.00**;

2. **THIS COURT ORDERS AND ADJUDGES** that the above amount will accrue pre-judgment interest at a rate of 18% from November 05, 2023, until the date of this Judgment;
